



## **Assembly Preparation**

### Before Beginning:





Unpack all hardware bags and components to ensure you have all parts.



Read instructions, cover to cover.



Have 2 adults on hand for assembly.



Do not assemble on flooring or carpet.



Assemble on a clean non-marring surface (packing foam).



Save all packaging until finished.





## Assembly Steps


**NOTE:** It is strongly recommended that two adults are on hand for the assembly of this product.

#### Step 1




Using a second person to assist you, place Right Leg Frame (B) on its side on a padded, non-marring surface. Align wooden tenons and the 2 mounting holes on Seat Frame (C) with the corresponding pre-threaded holes on Right Leg Frame (B) as shown. Secure Seat Frame (A) to Right Leg Frame (B) using Long Allen Bolts (H-2). Engage bolts **but do not fully tighten** them using Allen Key (H-6).

#### Step 2




Align wooden tenons and the 2 mounting holes on Seat Frame (A) with the corresponding pre-threaded holes on Left Leg Frame (C) as shown. Secure Seat Frame (A) to Left Leg Frame (C) using Long Allen Bolts (H-2). Engage bolts **but do not fully tighten** them using Allen Key (H-6).

## Assembly Steps




Flip assembly onto legs. Alight Backrest Weave Frame (D) with the Seat Frame (A) as shown. Secure Backrest Weave Frame (D) to Seat Frame (A) using Allen Screws (H-3), Flat Washers (H-4) and Spring Washers (H-5), stacking the hardware in the order as shown. Engage screws **but do not fully tighten** them using Allen Key (H-6).




Align Armrest Frame (E) to Right Leg Frame (B) and Left Leg Frame (C) as shown. Secure Armrest Frame (D) to Right Leg Frame (B) and Left Leg Frame (C) using Short Allen Bolts (H-1) and Flat Washers (H-4) and Spring Washers (H-5), stacking the hardware in the order as shown. Engage bolts **but do not fully tighten** them using Allen Key (H-6).

## Assembly Steps

#### Step 5



Align the Backrest Weave Frame (D) to the Armrest Frame (E) as shown. Secure Backrest Weave Frame (D) to Armrest Frame (A) using Allen Screws (H-3), Flat Washers (H-4) and Spring Washers (H-5), stacking the hardware in the order as shown. Engage all screws first, then **FULLY TIGHTEN all Bolts (H-1), (H-2)** and Screws (H-3) from this and previous steps with Allen Key (H-6).



Place Seat Cushion (F) onto Seat Frame assembly as shown, making sure the cushion sits flush along the back of the frame assembly. Next, place Pillow (G) against the back assembly. Using a second person to assist you, place the completed assembly into the desired location and then finalize any leveling adjustments using the adjustable levelers as shown.

Assembly is now complete and the product is ready for use.

**CAUTION:** Adjust pre-installed levelers only **AFTER** the unit has been moved into the desired location for use. **DO NOT** drag the unit as this may damage the levelers.

## Care & Maintenance



• Do not put hot items directly on furniture surface.



• Do not clean furniture with harsh cleansers or polish.



Do not place furniture near heating or cooling vents.



• Do not write on furniture without a padded barrier to protect the surface.



• Store furniture or use an appropriate furniture cover during cold or inclement weather.

• Dust and pick-up spills using a clean, non-colored, lint-free cloth.



Stains may be removed with mild soap solution and damp cloth.

**CAUTION:** As with any wood, the color may fade if left in direct sunlight or inclement weather. Minor cracking may occur with age. These are naturally occurring features of wood and do not affect product performance.

We recommend using our Outdoor Wood Furniture Finish sold separately to help preserve and protect the wood and finish.

#### **WORLD MARKET**. LIMITED ONE-YEAR WARRANTY – Outdoor Furniture

For your customer satisfacti , this product carries a LIMITED ONE-YEAR WARRANTY from the date of purchase. This limited warranty only applies to World Market brand furniture, and not to other furniture brands sold on World Market's website.

Where applicable, the limited warranty provides coverage for:

- 1. Manufacturing, Material and Workmanship Defects: Includes defects related to core frame/structure substrates (wood, metal and stone/tile); complete breakage of hardwood; cracking, split ng o or lifg of wood veneer or laminated top surfaces caused by process failure; broken welds or improperly coated metal frame components (powder coating or pai ted); outdoor fabric,, nautal rope and woven Textlene® defects including tears, misprints, fraying, crease marks, skip stit hes or open seams; syntheec resin wicker breakage or unraveling; and other component failures that are a direct result of manufacturing or workmanship defects.
- 2. **Cushions:** Loss of resiliency from a material breakdown of foam or fiber filling, which should not be confused with softeni g oor seling during normal use.
- 3. Outdoor Furniture Components (Hardware & Mechanisms): Includes defects to pre-installed components or hardware provided to the customer for assembly such as metal bases, swivel plate mechanisms; for umbrellas, canopy crank mechanism, spring loaded pole pins (for adjusting height); and other components such as bent or stripped threaded leg posts and adjustable levelers. Coverage also includes protectin against rust and corrosion on hardware. For missing, damaged, corroded, or misplaced hardware components such as bolts or washers, please contact Customer Service at: 877-967-5362.

#### This LIMITED ONE-YEAR WARRANTY does NOT cover:

- 1. Damage due to mishandling during transportati n from store or transporttat n without original protecective kaging.
- 2. Abuse, negligence (product misuse), improper storage, stacking or wear and tear that may result in or from:
  - a. Wood & Veneer: Mishandling, prolonged exposure to moisture, peeling or discoloration caused by exposure to moisture or excessive sunlight, heat; splintered, dented or nicked panels, legs or component edges or paint/finish blemishes; or treatment with corrosive chemicals (dyes, inks, paints or harsh cleaning products). NOTE: As with any outdoor rated wood, the color may fade if lef in direct sunlight of inclement weather. Minor cracking may occur with age. These are naturally occurring features of wood and do not affect product performance.
  - b. Fabric (Including Sunbrella® Fabrics), Rope, Textilene®, All-Weather Wicker: cuts, punctures, tears, burns, pet damage, or treatment with corrosive chemicals (dyes, inks, paints or harsh cleaning products), exposure to fire, high heat, water, or prolonged exposure to direct sunlight that may cause split ng, peeling, fraying or discolorati n with time.
  - c. Foam (Cushions): Flatening, relaxing oor seling/sosofteg of foam components that comes with normal
  - d. **Hardware Components:** improper installation o misuse/subsstit on of hardware components not defined in the Assembly Instructions fo the product (if applicable)
- 3. Damage due to prolonged environmental/inclement weather exposure such as direct sunlight, extreme heat, water or extreme humidity, strong winds, any bright light source (natural or articial), chlorine or saltwater pools, or any environment that the product is not intended for. We HIGHLY recommend storing furniture, umbrellas and cushions with outdoor rated furniture covers and out of direct exposure during the winter or inclement weather events.
- 4. This warranty is applicable for outdoor furniture products purchased for residential use only
